(3) GANTT CHART UPDATE

Mr. Wright commented the schedule has changed since February. We are approximately a week behind from the previous Gantt Chart, but still essentially on schedule if these reports are endorsed by the committee tonight. The 30-day public consultation will now run mid-May until mid-June.

(4) IPZ-3 MODELING STUDY AND PRESENTATION

Mr. Wright introduced Kent Buchanan and Gary Deonarine from Stantec who have

been involved in the process since the beginning. They looked at four spill sites and transportation corridors. The IPZ-3 was very small in Port Colborne, Welland was much larger. Waves were not part of the evaluation, but wind was. Dr. Alex McCorquodale was the engineer subcontracted to perform the contaminant modeling. Benzene was the solution they were assessing.

Mr. Wright suggested if the committee is interested in more details with the appendices we can have another meeting to discuss this. Mr. Deonarine expressed a really good working relationship with the Region and NPCA.. There was a lot of headway made with Conservation Authorities and the Region with criteria, and it is a tool to be utilized for the SPP. The Chair commented it is important that the modeling was completed especially with the recent fuel spill in Port Colborne.

The Chair asked if anyone wanted a hard copy of the report, please advise staff, and he thanked them for the presentation. The following resolution was then presented:

(5) SOURCE PROTECTION PLAN (SPP) 35-DAY CONSULTATION RESULTS

Mr. Wright gave a high-light of the table showing the summary of comments and proposed changes to the SPP. The majority of the comments that had to be changed were from the MOE, so the table is sorted by the various organizations. There is a significant difference compared to the last draft SPP the committee received, mainly due to the rewording of some policies. This did not affect the intent of most policies however.

Ms. Bellantino-Perco questioned changing Policy PC-13 from land use planning to a legally non-binding agreement applied to Transport Canada. Mr. Westlake responded recent legal direction stated that land use planning cannot be used to address the establishment of an airport. However section 57 can be used to prohibit this threat or section 58 to manage it.

Mr. Bator inquired if the province has committed to doing signage. The Chair informed everyone, that discussions with the Ministry of Transportation (MTO) are still ongoing, and it would be advisable to include a signage policy such as the standard policy suggested by MTO. It is currently a strategic action policy, therefore it is not mandatory and would be up to each municipality to decide whether to adhere to it. The following resolution was then presented.
