BUSINESS:

(2) BUSINESS ARISING FROM THE MINUTES

Mr. Shrive mentioned the City of Hamilton has requested one of their planners join as a member of the working group. Mr. Wright explained the draft policies currently being prepared are based on the IPZ's, none of which are in Hamilton. It was suggested to amend the SPP working group resolution with regards to members, and the following resolution was presented.

Ms. Bellantino-Perco inquired about the Transportation Threats report. Mr. Wright explained he was waiting for clarification from the MOE whether the calculations for the vulnerability scores for diesel are based on a direct or indirect spill. Mr. Wesley Wright advised this is a priority, and the decision will be made very soon. A copy of the report will be e-mailed to committee members.

(3) GANTT CHART UPDATE AND SPC MEETING SCHEDULE

Mr. Wright said there were no changes to the Gantt chart, and so far we are on schedule. The SPC meeting scheduled for April 12, 2011 will be postponed until Tuesday, April 19, 2011.

(4) PRESENTATION ON THE LAKE ERIE BINATIONAL FORUM & THE LAKE ERIE MANAGEMENT PLAN

The Draft Nutrient Management Strategy was recently completed for the Lake Erie LaMP. The NMS looked at nitrogen, lead, and phosphorus loadings in Lake Erie as well as algal growth in the lake due to the nutrient loadings. The NMS sets target limits for phosphorus in Lake Erie. The limits vary depending on the section of Lake Erie. The targets are less stringent for the shallower western section of the lake adjacent to the State of Ohio, compared to the eastern section which is deeper. Nitrogen concentrations are expected to likely parallel the growth of phosphorus in the lake. Mr. Renshaw suggests that the SPC follow developments on the NMS and perhaps submit comments during the consultation process. He also suggests that NPCA may want to participate in the Lake Erie Bi-National Forum. Mary Stack indicated that NPCA may not have the resources to participate fully in this forum, but we are involved in the Niagara River Remedial Action Plan (RAP).

SWP staff to investigate how other SPCs are interacting with LaMPs for Phosphorus targets.

Mr. Renshaw will provide web links so NPCA can pass them onto the SPC members. Mr. Wright will pass the draft document onto NPCA's Water Quality specialist, who is doing some work for the Niagara River RAP, for his comments.

(5) BACKGROUND REPORTS AND SPP UPDATE

Mr. Wright introduced Ms. Jessica Button, NPCA Source Protection Planner. The NPCA prepared the three threat background reports by adapting Cataraqui CA background documents. The following resolution was presented:
