(2) BUSINESS ARISING FROM THE MINUTES

Mr. Bator inquired under Item 12 - Other Business, if the culverts will be covered. Ms. Barrow replied they will be covered over by dirt. Mr. Renshaw asked if changes could be made to the Assessment Report and Source Protection Plan after the public consultation. Mr. Wright replied as long as they are done before submission to the SPA.

(3) UPDATE FROM THE CHAIR

The Chair stated if everything is passed at this meeting tonight, these documents will be presented to the SPA next week, and could be submitted to the MOE by the end of the month.

There is an upcoming Chair's and Project Manager's meeting November 4th and 5th in Toronto with regards to the implementation phase.

The Chair announced Ms. Elizabeth Evans is leaving her position as the Risk Management Official / Inspector and moving on to the private sector. A new resolution will have to be brought forward to council designating this to a position, not a specific person. In the interim, Ms. Deanna Barrow has the qualifications for this position although she is not using the designation.

(4) GANTT CHART OF TASKS FOR 2013

Mr. Wright explained there are only a few tasks left, as the Chair mentioned previously we are on the last stretch. If everything is approved tonight this will go to the SPA next Wednesday. It will take approximately a week to assemble the package and submit it to the MOE, so hopefully by the end of October this can be accomplished.

(5) RESULTS OF 30-DAY PUBLIC CONSULTATION PERIOD

The Chair mentioned only a few people from the public sector showed up for the open house meetings. No written comments were received from stakeholders, only from the MOE. He also commented these sessions were very informative and useful, and then asked Mr. Wright to go through the report. The following are the recommended actions:

Table 1: Assessment Report Comments:

- A sentence was added concerning the uncertainty of modelling for Lake Ontario as requested by the MOE;
- Table 8.6 revised to show that only pathogen threats are significant in IPZs with vulnerability scores of 9 or 8.1 as requested by the MOE.

Table 2: Source Protection Plan Comments:

- Delete Transport Canada from PC-14 & G-8 and revise Table 4.2;
- Revise appendix C, Table C.1 for DC-7, PC-24 & NF-6 applies to EPA and Nutrient Management Act – NASM Plans. Revise ED to be consistent with the SPP;
- Revise Table 4.1 so that PC-8 & PC-10 apply to road salt, PC-9 applies to snow and PC-11 to both. Revise ED as needed;
- Add IPZ-2 reference to the policy and delete reference to 2500 kg;
- Clarify that PC-28 should also be considered for areas where local threat policies apply;
- Revise preamble to Table 4.12 to indicate PC-30 & PC-31 apply only to Port Colborne IPZ-1 for transportation threats, and revise schedule PC3;
- There were also a few minor, administrative corrections;
- A preliminary pre-consultation comment was received from the MTO, indicating
 they can implement the policies in the SPP. They haven't had the opportunity
 to speak to the Area Maintenance Contractor regarding these policies and are
 currently in the process of contacting them. However, they haven't gotten back
 to staff to confirm this.

Table 3: Explanatory Document

• Rationale for policy G-5, Ministry of Agriculture and Food has to be inserted as an implementer;

- Policy WL-3, insert MTO as an implementer;
- Remove WL-5, and delete reference to Niagara Region;
- The recommended action for item 4 on the chart applies to item 3;
- Section 6.5 and 7.11 Add a sentence to emphasize that the IPZ-3 where the signage policies are to be applied indicating that fuel spills along these corridors could be significant threats. This would make it clear to MTO why we would want signs there;
- PC-27: Revise so the whole pesticide rationale applies to the IPZ-2 as well;
- Delete the reference to policy PC-32 in the Transportation Threats write-up, since PC-32 applies only to fuel threats and not to NASM/ASM threats;
- Policy M-1: Change M-1 to M-3, DC-9 to DC-10 and PC-30 to PC-31;
- Policy M-7: Insert policy PC-13;
- Policy M-11: Insert policy WL-3.
