### (2) <u>BUSINESS ARISING FROM THE MINUTES</u>

There was no business arising from the minutes.

# (3) <u>UPDATES from the:</u>

## <u>CHAIR</u>

The Chair mentioned there was a Source Protection Authority Meeting February 20, and Mr. Proks will cover this in greater detail. An SPC on-boarding and IPZ tour took place March 7th with committee members, the interim CAO Ms. Wood, staff and a few board members in attendance.

There was a Chair's meeting held December 10, 2018 and the Chair attended a Halton Hamilton SPC meeting on December 11, 2018.

On January 24, 2019 SPC Chairs met with Minister Rod Philips, and there were three issues for the government:

- 1. Affordability for families;
- 2. Competitiveness for the economy; and
- 3. Finding balance.

The Chairs covered a number of issues including:

- Future of the program and ongoing provincial financial investment.
  - The minister's request was that a business case be put together to continue the program;
- Source protection for northern communities and vulnerable populations
  - The minister's request was to determine how to operationalize this.

The Chair reiterated our work is still important and relevant.

### PROJECT MANAGER

Mr. Proks stated since the last meeting, items to update the committee include:

- Knowledge transfer with Jayme Campbell has been on-going since December and Jayme has been retained until the end of March. Overall the process has been quite successful, and highlights of the orientation include:
  - Teleconference orientation session with Chitra at Conservation Ontario
  - o IPZ tour and on-boarding SPC / SPC in March
  - Attendance at Lake Erie Region and Hamilton-Halton SPC meetings.
- Attended the Groundwater Open House in Guelph late February. A very interesting conference with the following being some key highlights:
- A very interesting presentation from Tessa Di'lorio (Hydrogeologist at the City of Ottawa)
  - New City of Ottawa Hydro-geological guidelines for rural property development: (i) is there enough water? (ii) is the quality suitable? (iii) how to deal with the septic impacts?
  - They are starting a test project for the guidelines in March 2019 and hopefully they will be in place at the end of this year
- Another good presentation from Laura Colgrove (Western University) and Stu Hamilton using the data from all across Southern Ontario and plotting the major ions which is than used to map the elevated regions in Southern Ontario.

Niagara specifically has the following elevated parameters within the region: fluoride, chloride, selenium, boron, iodide, arsenic, uranium, hydrogen sulfide and some bacteria hits. This report will be summarized at the next committee meeting and showcase all the maps and results.

Mr. Proks mentioned there is a new Director of Watershed Management, Darren MacKenzie who some of you met on the morning of the on-boarding session, and he sends his regrets he was unable to attend tonight's meeting.

One of the outcomes of the SPA meeting held February 20 was to re-appoint Member Dalimonte as the Municipal Representative for Haldimand County and Member Rigby has been appointed as the Municipal Representative for Niagara Region. Also Mr. Wright has been appointed the SPA Liaison.

On December 3, 2018 we received the Section 36 order from the province and this will be discussed in report SPC-01-19.

### LIAISON OFFICER, MECP

Ms. Forrest announced Ms. Susan Ecclestone is the new Director for the Source Protection Programs Branch. The Section 34 amendments have to be approved by the Minister. Currently they are working through 15 updates for Section 36 workplans.

The Source Protection Public Mapping Tool has been updated, and public consultation is underway for "Made for Ontario."

## (5) <u>REPORTS</u>

## SECTION 36 AMENDED ORDER - REPORT NO. SPC-01-19

On December 3, 2018 the NPSPA received the amended Section 36 Order from the MECP. The order states that the Source Protection Committee shall update the AR and the SPP to address the following workplan items:

- "reflect the planned changes at Niagara Falls, DeCew Falls, Rosehill and Welland water treatment plants (section 2 of the workplan)";
- "comply with the amendments made to the Director's Technical Rules, published on the Environmental Registry in March 2017 under posting number 012-8507. In particular for your source protection area, this includes assessing the vulnerability of the Port Colborne drinking water intake (section 3.1 of the workplan) and locations where the above grade handling and storage of fuel poses a significant risk"; and
- "assess the new drinking water threat of provincial interest recently added to the General regulation (O.reg. 287/07) under the Clean Water Act – the establishment and operation of a liquid hydrocarbon pipeline (section 3.2 of the workplan) in accordance with the Director's Technical Rules" (MECP, 2018)

The funding request has been submitted for this. To date we have been granted the funding requested and are optimistic we will receive the funds for the coming year. The following resolution was presented:
