CHAIR

PROJECT MANAGER

Mr. Proks provided the following updates to the Source Protection Committee:

 The 2019 Annual Report was presented to Source Protection Authority Board virtually on April 15, 2020. It was approved by the SPA and submitted to MECP

- before the deadline of May 1st, 2020. The public facing report was posted to the Niagara Source Protection website.
- There was a virtual Project Manager and Chair meeting held on May 26, 2020 where highlights from the 2019 annual progress results were provided and a reminder that the changes to the Director's Technical Rules will be posted to the EBR soon.
- Jen Croswell could not attend the meeting so updates on her behalf are as follows:
 - o Niagara has incorporated the technical requirements into all of the upcoming intake projects, which are at various stages of planning/design.
 - Following MECP's lead as to how to approach onsite RMP inspections, as of right now inspections are on hold.
 - Niagara has a draft communication/education and outreach plan scheduled for this year, now on hold due to shift of priorities caused by the pandemic
 - Children's Water Festival was cancelled, festival partners collaborated to put together a virtual festival with water protection as the first topic
 - Pandemic impacts to Water and Wastewater are minimal, safe work protocols were implemented and are still being practiced. Business as usual and remote work where possible.

MECP LIAISON OFFICER

Updates provided by MECP Liaison are as follows:

- The changes to the Director's Technical Rules will be posted by the end of the summer, hopefully, and will have a 90 day comment period on the EBR.
- Some SPAs extended deadlines for Annual Report submission to July 1st, due to the pandemic.
- Transfer Payment Agreements for the 2020-2021 funding year have now been approved.
- Significant updates were made to the Source Protection Information Atlas and an overview could be provided to the SPC if desired.
