CAO Sharma provided the following updates to the Source Protection Committee:

- Province is implementing a technical guidance document re: private wells for community and municipal input. Niagara would be a good pilot to provide input and promote the guide. No schedule was given for implementation.
- CAO Sharma echoed the Chairs comments regarding the Province's commitment to continue funding the program.
- A Terms of Reference for the Source Protection Committee highlighting role and responsibilities is being worked on alongside Conservation Ontario.
- New Director of Watershed, Leilani Lee-Yates was announced.

# PROJECT MANAGER

Mr. Proks provided the following updates to the Source Protection Committee:

- 2020 Report was approved by SPA, was sent to Ministry, now posted on NPCA website.
- Draft technical work, of IPZ delineation was forwarded to Ministry for review.
- Decew Falls updates have been deferred, likely until 2026.
- Welland Water Treatment Plant is at 40% design.
- Regulatory Proposal Consultation Guide was posted by M.E.C.P. which includes changes of Bill 229 affecting the Conservation Authorities.
- 2021-2022 yearly Transfer Payment Agreement has been signed and received.
- Fuel handling storage and pipelines policies was submitted to Ministry for review and comment. No comments or edits were provided by the Ministry.
