Recommended: Create a new policy like PC-24 that is specific to the Port Colborne IPZ-1 and identifies the handling and storage of Categories 1 through 3 NASM in quantities greater 5 tonnes as a significant drinking water threat (i.e., No new Category 1, 2 or 3 Non-Agricultural Source Material handling and storage, shall be permitted

within the Port Colborne IPZ-1). Even though the activity is realistically not taking place within the Port Colborne IPZ-1, this approach would be consistent the NPSPA previous approach of writing policies despite the activity not taking place (i.e., aircraft de-icing policy for Port Colborne IPZ-1)
