#### (3) GANTT CHART UPDATE

### (7) UPDATE FROM THE CHAIR

The Chair attended a conference, and the Fort Erie Rosehill Plant was judged to have the best tasting water in Ontario.

The Chair participated in a conference call involving the MOE, SPC Chairs and Mr. John Stager with regards to the Great Lakes Protection Act. This is currently posted on the EBR, and he recommended you take a look at this. They wondered if any Source Protection Committees would be interested in the infrastructure set up. The Chair thought we might be interested in this process but is unsure what is involved and what is expected, so just wait and see and take it from there.

The Chair informed the committee a meeting in July will not be necessary. On August 14th, the SPC and NPCA staff are invited for a barbeque and meeting at the Chair's house. He will e-mail everyone with a meeting time and provide directions.

#### (8) <u>OTHER BUSINESS</u>

The Chair mentioned there was a package included in the agenda submitted by Mr. Bator. The first part is pieced together of source water protection in various cities in the United States. They are developing watershed plans in accordance with the Environmental Protection Act approach. Their approach is more volunteer oriented, and a lot of the costs are paid by the water treatment department which is passed on to the consumer.

In Michigan, their SWP is divided into short term (3 years), medium (5 to 10 years) and long term actions (up to 50 years). Under the USA Clean Water Act, information on the watersheds was collected, issues were defined and goals were established. Success of the implementation is measured on a regular basis.

The Massachusetts Water Resources Authority has been attempting to work with the railroad industry because a railway accident is a potential source of contamination. However, working with them has been challenging due to the unique set of rules, similar to our transportation threats with the Seaway.

The biggest concerns based on a survey conducted by The American Water Works Association were:

- 1. Oil and fuel spills;
- 2. Algae growth, and;
- 3. Bacterial pathogens.

The Chair requested everyone take a look at the last page of the handout. Mr. Bator commented once a year a chart like this is published showing the bypasses and spills that are reported in each municipality. The Chair thanked Mr. Bator for his report, and he responded he thought it would be a good discussion point.

Mr. Bator attended an Agricultural Representative's meeting for Source Water on May 29 & 30. They are working on putting together documents for the Risk Management Plans. Mr. Bator will keep the Source Protection Committee up to date, and liaise with the Niagara Region's Risk Management Official Ms. Elizabeth Evans.

Mr. Wright will communicate with the SPC with regards to the SPA submittals.
