(2) BUSINESS ARISING FROM THE MINUTES

The Chair noted that Mr. Renshaw's presentation will be delayed until the next meeting, due to his absence.

(3) SOURCE PROTECTION PLAN – GANTT CHART UPDATE

Mr. Wright noted the only change was submitting the updated Assessment Report by May 30, 2011 instead of June, 2011. The work plan for the UAR was one of the first submitted to the MOE, so hopefully we will receive their approval soon.

(4) SOURCE PROTECTION PLAN (SPP) – SIGNIFICANT THREATS IN SPA AND MOE GUIDANCE MATERIALS

Mr. Wright explained this report outlines a summary of the significant threats for the NPSPA. The spreadsheet gives you an idea of all the different chemical and pathogen circumstances which must be addressed. The flowchart shows that a lot more preconsultation is required before the Draft Proposed SPP goes to the public, compared to the requirements of the Proposed Assessment Report. Ms. Bellantino-Perco questioned if this process is the same as the AR. Mr. Wright replied, the Preconsultation involves direct communication with municipalities, stakeholders, and also agencies that issue provincial instruments (such as Certificates of Approval), etc.

These bodies are then required to provide back comments on the proposed policies. The consultation requirements *after* the draft proposed Source Protection Plan is released to the public are very similar to those of the Proposed Assessment Report.

(5) TRANSPORTATION CORRIDOR THREATS

Mr. Wright noted this report includes a letter similar to the one Cataraqui Source Protection Region submitted which was recently approved by the MOE. Mr. Ostryhon inquired where they were located. Cataraqui is in the Kingston area, so it has similar shipping and roadway corridors like Niagara Peninsula.

Ms. Barrow felt the letter was a little strong, and suggested re-wording the sentence on the last page, third paragraph to read, "...it was decided that the WTP should be shut down for 12 hours as a precautionary measure until the testing was completed." Mr. Rigby wondered if it was automatically required to shut down the plant, and Ms. Barrow will check the ERP and let us know.

Ms. Bellantino-Perco questioned how Table 2 was compiled. Mr. Wright thought it was part of Stantec's research, but he will confirm. She also requested the committee receive a copy of the Stantec Transportation Threats Report.

Mr. Bator asked why the records for the years 2003-4 and 2009-10 aren't shown on Table 3. Mr. Wright commented the footnotes explain that this information was not yet received, and if the information isn't received by the time the work plan is due, it will have to be left as a data gap. However, this should not affect the results of the transportation threats report.

A suggestion that only show spills greater that 100 litres in size be included in Table 3 was discussed but eventually it was decided to leave Table 3 as is, showing *all* spills that were recorded in the Spills Action Centre Database. The following resolution was then presented:

The Chair also sits on the advisory committee which Conservation Ontario chairs, and they have teleconferences every two weeks focusing on the structure of policy planning. The Chair informed everyone that this was Ms. McHugh's last meeting for some time, due to maternity leave, and her last official day is November 5, 2010. On behalf of the committee he thanked her for her hard work, and wished her the very best. Ms. McHugh said the MOE just hired a new liaison Mr. Wesley Wright, but unfortunately he could not attend the meeting this evening. She commented that she has enjoyed working with this committee, and will try to follow our progress on the SPP.

(8) OTHER BUSINESS

In answer to a SPC member question, Ms. McHugh stated that orders and amendments to prescribed instruments made under the SPP for prescribed instruments may be appealed to the Environmental Review Tribunal (ERT).

The SPC could write a *Strategic Action* type policy to cover threat activities on the Welland Canal, but since the Seaway Authority has federal jurisdiction, they don't have to comply.

Mr. Semple asked if an appeal can be made to the OMB for land use. Ms. McHugh is going to check on this.

Ms. Bellantino-Perco inquired about the upcoming training in Brantford. Everyone should receive their confirmation with an itinerary via e-mail the week of October 12, 2010.
