(3) UPDATES from:

NPCA CAO

Ms. Wood thanked the committee for the opportunity to speak before her departure at the end of this year. She is pleased to announce 80% of the Auditor General's recommendations are complete. Further updates include:

- Staff reorganization is complete;
- Terms of Reference for many committees has been updated;
- No news on the appointment of a new Chair for this committee;
- There is currently an offer out to a new CAO, but she is not at liberty to announce until it is finalized:
- She has been appointed to the NPCF by the Board of Directors, so still will be in the office occasionally;
- Finally, she would like to commend this committee for their time and dedication, the Authority is very appreciative.

ACTING CHAIR

The Acting Chair mentioned there was a presentation to the Board of Directors at the Full Authority meeting held November 20. The main intention was to educate the new members to the Board of Directors about Source Protection and to update the SPC Rules and Procedures.

PROJECT MANAGER

Mr. Proks informed the committee there is still no update on the Chair's re-appointments, and Mr. Willems is willing to continue to as Acting Chair. In November, the funding application process was initiated by The Source Protection Programs Branch and to date, approval by the province has not yet been received to provide the funding.

Also, in November the technical session for the upcoming changes to the Director's Technical Rules was held. Attached to your agenda package there is an appendix that lists all the proposed changes.

The updated committee members handbook was approved at the Board of Director's meeting in November and requested the committee members sign the master copy here this evening, so we have it for our records.

Lastly, Niagara Region is currently in the Environmental Assessment Addendum process for the Niagara Falls intake relocation. A section of the report includes the Source Water Protection considerations and if you are interested, he will e-mail the website link.

LIAISON OFFICER, MECP

Ms. Beth Forrest said currently the Ministry is receiving feedback on Phase 2 Technical Rules. Timelines are unclear and going forward with engagement session. The first Section 36 was received in October and has been approved. Also, all funding applications have been received. Last thing, the moratorium on water bottles has been extended to review what is mandatory and what is not.

The committee directed staff to gather more background information on sewage threats within the Niagara Peninsula Source Protection Area and Mr. Proks did a PowerPoint presentation. Sanitary sewers exist within IPZ-s for all 6 water treatment plants. Potential impact likely only exists for Port Colborne, although changes to the Director's Technical Rules may result in changes to scoring. Discussion ensued. Ms. Croswell will

bring back to the committee the monitoring process the Region performs on the sanitary sewers. The following resolution was presented:
